# GENERAL REQUIREMENTS FOR VISA APPLICATIONS

- 1. FULLY COMPLETED VISA APPLICATION FORM 1 (APPLICANT)
- APPLICANT'S CERTIFIED COPIES OF PASSPORT PAGES (Showing Validity, Photograph & History)
- 3. TWO RECENT COLOURED Passport Size Photos
- 4. COVERING LETTER FROM HOST.
- 5. IF PREVIOUSLY APPLIED FOR VISA PLEASE ATTACH THE COPY OF THE OUTCOME.
- 6. IF COMING BY ROAD PLEASE SPECIFY ON THE COVERING LETTER
- 7. TRAVEL SCHEDULE/ FLIGHT ITINERARY/BOOKINGS

NB: COPIES OF DOCUMENTS CAN BE CERTIFIED BY ANY COMMISSIONER OF OATH

#### ADDITIONAL REQUIREMENTS:

### VISITORS VISA:

- a) P300 Single Entry for a period up to 3 months
- b) P500 Multiple Entry for a period up to 3 months
- c) P1500 Multiple Entry for a period over 3 months to 2 years for dependants of residents
- 1. SWORN STATEMENT/AFFIDAVIT FROM THE HOST (Personal Appearance of the Host for Oath)
- 2. COPIES OF MARRIAGE /BIRTH CERTIFICATES (SPOUSE/DEPENDENTS)
- A CERTIFED COPY OF HOST'S NATIONAL IDENTITY/ RESIDENCE & WORK PERMIT/ EXEMPTION CERTIFICATE
- 4. CERTIFIED COPIES OF ORDINATION CERTIFICATES FROM RELIGIOUS LEADERS
- 5. RETURN VISA OR RESIDENCE PERMIT FROM COUNTRY OF RESIDENCE

## **BUSINESS VISA:**

- a) P500 Single Entry- For a period up to 3 months
- b) P1000 Multiple Entry For a period up to 3 months
- c) P1500 Multiple Entry- For a period of 6 months to 1 year
- 1. BUSINESS PROFILE/ LETTER OF INVITATION FROM HOST ORGANISATION
- 2. MEETING SCHEDULE (If coming to attend or organize a meeting)
- 3. CERTIFIED COPIES OF TRADE LICENSE, CERTIFICATE OF INCORPORATION, SHARE CERTIFICATE OF HOST IF OPERATING A BUSINESS

#### **EMPLOYMENT VISA**

- a) Gratis
- COPIES OF WORK AND RESIDENCE PERMITS/ EXEMPTION CERTIFICATE FROM THE COMMISSIONER OF LABOUR
- 2. LETTER OF EMPLOYMENT OR CONFIRMATION OF EMPLOYMENT

#### **INVESTORS VISA**

- a) P1000 Multiple Entry for a period up to 6 months
- b) P2500 Multiple Entry for a period up to 5 years
- 1. COPIES OF WORK AND RESIDENCE PERMITS
- 2. CERTIFICATE OF INCORPORATION, TRADE LICENSE, SHARE CERTIFICATE & LIST OF DIRECTORS.

## **TOURIST VISA**

- a) P300 Single Entry for a period up to 1 month
- b) P 500 Multiple Entry for a period up to 3 months
- 1. TOUR PLAN OR COPY OF TRAVEL SCHEDULE
- 2. HOTEL BOOKINGS

## STUDY VISA

- a) Gratis
- 1. ADMISSION LETTER
- 2. FINANCIAL CONFIRMATION (SOURCE OF INCOME FOR THE SCHOOL FEES)
- 3. STUDY PERMIT

## TRANSIT VISA

- b) P300 Single Entry for up to 1 week
- c) P500 Multiple Entry for up to 3 months
- d) P1500 Multiple Entry for up to 3 years for Tour Operators and Transporters
- 1. COMPANIES /INDIVIDUAL LETTER
- 2. RETURN VISA OR PROOF OF RESIDENCE AND VISA FROM COUNTRY OF DESTINATION

NB: COPIES OF ALL REQUIRE DOCUMENTS SHOULD BE CERTIFIED UPON COLLECTION OF OUTCOME PLEASE BRING DOCUMENTS OF IDENTIFICATION AND ORIGINAL PAYMENT RECEIPT.
